



Your right to privacy while using the World Wide Web is very important to Kids Wish Network, Inc. ("KWN"). KWN is committed to helping you maintain control over your personal data while fostering the growth of a more interactive, engaging, and personalized web experience. We respect your right to control how much information you provide about yourself. When you are making a donation, purchasing a product, expressing an interest in referring a child or facility for one of our programs, or subscribing to our online newsletter, we ask you for personal contact information such as your name, mailing address, phone number and e-mail address. We may use this contact information to provide you with a receipt or financial report; to contact you to clarify or obtain information about an order you placed, a donation you made, or a child or facility you have referred; or to send you additional information about KWN. If you make a donation, we may contact you from time to time to offer you an opportunity to make another gift, or to offer services from third parties that will directly benefit KWN. From time to time, KWN rents or exchanges its list of supporters with other trusted organizations to benefit KWN, its programs and activities. KWN provides an opportunity allowing you the option to opt-out on all KWN and affiliated Web sites. The following Privacy Policy ("Policy") describes how we collect, protect and use information we receive from visitors to KWN and affiliates web sites, including KidsWishNetwork.org, KidsWishNetwork.com, Winthevettes.com, and Corvettedreamgiveaway.com (the "Site(s)"). By using one of our Sites, you agree to the terms of this Policy. This Privacy Policy applies only to information collected through our Sites and not to information collected offline.

## **1. What Personally Identifiable Information Is Collected**

We do not collect personally identifiable information on our Sites unless you voluntarily provide information about yourself via an electronic mail message or by filling out one of our online forms. By "personally identifiable information," we mean data that is unique to an individual, such as a name, address or telephone number. For example, if you send us an email or call us, we may use the information you provide to follow up via telephone or email. The information you provide will be kept confidential and will be used only to support your continued relationship with KWN.

We may conduct contests, sweepstakes and surveys through our Sites. We request contact information from you in connection with your participation for the purpose of conducting the promotion. Any personal information collected may be used by us or the sponsors of the contest, and may be associated with registration information.

No software or hardware techniques are employed to capture a visitor's email address or other personally identifiable information. KWN does not monitor individual traffic patterns on our Sites, and we do not use invisible images to track how you use our Sites. Our hosting company may collect anonymous, aggregate information or statistics related to Site usage. These statistics indicate the total number of hits, the total number of page hits, the number of kilobytes transferred from our Sites, and the IP address of the visitor. If we decide to use this information to analyze Web traffic in the future, we will only be able to measure the number of visitors to our Sites and the addresses of the web sites from which our visitors come. email addresses and other personally identifiable information are not available to us unless you affirmatively supply such information.

## **2. How the Information You Provide Is Used**

Should you send us your comments or questions via email to any email address provided on one of our Sites, we will only share your communications with our employees or agents most capable of addressing your questions and concerns. We will retain your communication until we have done our very best to provide you with a complete and satisfactory response and then we will either discard it or, in some cases, archive it. We share your personal information with our agents, representatives, contractors and service providers so they can provide us with support services such as authorization of credit card transactions, order processing and sweepstakes fulfillment. From time to time, our advertising and promotional partners may desire to use information collected through our Sites to call to your attention to promotions and offers they believe might interest you. If you prefer not to receive direct communications sent by our advertisers or promotional partners, you will be given an opportunity to decline before you provide us any information we might use for this purpose. If you decline at the time you provide us with information, you will not receive email or other communications sent directly by our advertisers utilizing information collected from our Sites, though we may on occasion send you information on their behalf. In all cases, however, we will use your information only as permitted by law.

Except as provided herein, we will not disclose personal information unless we are required to do so by law or we in good faith believe that such action is necessary to (a) comply with the law or with legal process; (b) protect and defend our rights and property; (c) protect against misuse or unauthorized use of any of our Sites; or (d) protect the personal safety or property of our users or the public.

## **3. Security of Information Sent to Us**

Please note that, unless we expressly advise you otherwise, the e-mail functionality on our Sites does not provide a means for completely secure and private communications between us. Like all unencrypted Internet email communications, your email may be accessed and viewed by other Internet users, without your knowledge and permission, while in transit to us. For that reason, to protect your privacy, please do not use email to communicate information to us that you consider to be confidential. While we strive to protect your personal information, KWN cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk. Once we receive your transmission, we will use our commercially reasonable efforts to ensure its security on our internal systems. Depending on the nature of the inquiry, your communication may be discarded or archived.

#### **4. Security of Financial Transactions**

In addition to personal contact information, we sometimes ask for billing information, such as your billing address and credit card number when you make a donation, purchase a product, enter a sweepstakes, or participate in a fundraiser. All financial transactions on our Sites use an encrypted channel, take place on secure servers, and occur in real time. We use secure servers to gather and process your billing information. These secure servers are hosted by our agent Ultra Web Solutions, which is bound by our site policies. Your billing information is not shared with any other organizations, and your credit card number is not retained once your transaction has been authorized and processed. #### **5. Disclosure of Customer Information Through Transfers and Requests**

As we continue to develop, we may buy, merge or partner with other companies or businesses, and in so doing, acquire customer information. In such transactions, user information may be among the transferred assets. Similarly, in the unlikely event that a portion or substantially all of KWN's assets are transferred to a third party, the information you have voluntarily provided to us, including your email address, would likely be one of the transferred assets. In some instances, we ask for contact information for people other than yourself including, for example, email addresses of friends to whom you believe may have an interest in KWN or any of its activities, or the mailing address of someone you wish us to notify of a donation you have made. The information we collect is used to send the donation notification or information you requested and/or to inform the recipient of KWN updates, program information, and opportunities to get involved. Such contact information is not shared with any other organizations.

#### **6. Our Commitment to Children's Privacy**

We recognize the importance of protecting the privacy of children. KWN only collects personally identifiable contact information from children who are referred or referring themselves as potential program recipients, however we do not share it in any other way or with any other parties. We do not give the ability to publicly post or otherwise distribute personally identifiable contact information in any way. Sites that support KWN's programs, are directed to adults at least eighteen years old, and when a user discloses personal information through one of our Sites, the user is representing to us that he or she is an adult. If a child has provided us with personal information, that a parent or guardian wishes to be removed, email us at [info@kidswishnetwork.org](mailto:info@kidswishnetwork.org), and we will promptly delete the child's information from our records.

#### **7. Privacy Policies of Web Sites Not Under Our Control**

For your convenience, our Sites may provide links to various web sites that we do not control. When you click on one of these links, you will be transferred out of our Sites and connected to the web site of the organization or company that you selected. We are not responsible for the nature, quality or accuracy of the content or opinions expressed in such web sites, and such web sites are not investigated, monitored or checked for quality, accuracy or completeness by us. Inclusion of any linked web site through one of our Sites does not imply or express an approval or endorsement of the linked web site by us, or of any of the content, opinions, products or services provided on these web sites. Even if an affiliation exists between KWN and a third-party

web site, we exercise no control over linked sites. Each of these linked sites maintains its own independent privacy and data collection policies and procedures. If you visit a web site that is linked to or from one of our Sites, we encourage you to consult that web site's privacy policy before providing any personal information and whenever interacting with any web site.

## **8. Access and Correction**

You have a right to know about the personal information that KWN has collected through our Sites, including the right to correct, amend or delete the information that KWN has on file if it is incorrect. You may also change the status of whether you wish to receive alerts, newsletters and communications at anytime. KWN makes no warranties of any kind regarding our Sites, including but not limited to any warranty of accuracy, completeness, currency, reliability, merchantability, or fitness for a particular purpose, or any warranty that these pages, or the server that makes them available, are free of viruses or other harmful elements, and such warranties are expressly disclaimed.
